<p>Item 8 –Events Co-ordinator</p> <p>13. The Events Co-ordinator (EC) updated that the 2022 National events had taken place in Q1 which saw the male and female nationals split for numbers.</p> <p>14. Internationals 2023 are still to be confirmed less the WFP that is scheduled for Nov 2023 in Glasgow. It was confirmed that the BDFPA will be bidding for an international event each year.</p> <p>16. From 1st Aug there will no longer be a requirement for competition organisers to submit entry lists to the MR 2 weeks before events. The onus will now be on the competition organiser that the membership status of individuals is checked during weigh in. This includes people who have joined in the week prior who have not yet had their membership confirmed, in such cases individuals will be lifting classed as a provisional member and following successful membership confirmation will have their results ratified from the event they entered.
